COMMENTS FROM CITIZENS

Betsey Hampton – 242 Trail Ct., Newark – I want to comment regarding the re-zoning on River Rd. I want to ask City Council that when the re-zoning is considered that you take into account making sure the properties are set back enough so that it looks nice from River Rd. I also think that they should

allow space so that sidewalks or a bike path could be added along River Rd. Right now River Rd is hard for anyone to walk along and I think that as they're re-zoning properties they should make the neighborhoods more walkable and I think the time to do that is when new neighborhoods are being developed rather than waiting until later and trying to add them afterwards. Especially now I know in my neighborhood bussing is being cut for the high schoolers so it would be nice to have more walkable space for them. As it is right now there are no walking areas along River Rd. With it being a neighborhood full of houses I think we need sidewalks and street lights and everything that goes along with that. I think with any new development that City Council should work with the developers to make sure they are neighborhoods that look good for our community.

President Ellington – There are 3 pieces of legislation that refer to that this evening. They will be referred to Planning Commission tonight, They will have a public hearing in January of February, everyone will have a chance to give their input. The Planning Commission the following month will come back with their recommendation, it will come back to Council, we'll have another public hearing and then vote on that. I would say around March that will happen. Thank you for your input.

Marcia Phelps – Licking County Clerk of Municipal Court – work address 40 W. Main St. Newark, home address 205 Gladys Ave, Newark – see attachment for Ms. Phelps comments.

Additionally I wanted to ask about Resolution No. 20-97. Has that been tabled or is my section for \$6,500 being voted on tonight?

President Ellington – The section for your \$6,500 has been voted on and passed already tonight. If you stay on the meeting, when we get to Resolution 20-88, if anyone has any questions for you I will allow them at that time.

Marcia Phelps – I appreciate that and let ne reiterate that the two investigators involved in that report are also online tonight.

Caroline Cook – 898 Lateglow Ct, Newark, You may get tired of me but I do intend to keep speaking out at this meetings. I think that's my job as a caring and informed citizen. Recently I've seen various projects discussed in these meetings and in the Advocate. All of them involve development of one kind or another. They involve using tax money and some private contributions. They're to find projects to aid business development. These projects include making the highway systems better to help developers bring in resources, transport products, develop real estate, to make our downtown more interesting and exciting. I'm not opposed to business development, but I am concerned that we are not giving the same energy and monetary support to human development in our county. I think most of us can agree we have problems in providing a nurturing environment for many people in our community. There is a lack of affordable housing. Probelems with addiction, lack of transportation, lack of decent child care and preschool for many low income families. If you feel these problems don't exist here, then you must not live in the same Newark that I live in. I'll give you an example. I was driving down Church St. and there was an old guy with a beard riding a little bike, he fell down in the street in front of me. I stopped my car and he was laying in the street because I was afraid of COVID I didn't know what to do, but fortunately some young men around 18 years old were in a truck behind me and when I stopped my car, they stopped their truck. They got out and got the guy back up on his feet again. I have seen people riding bicycles in really cold weather, we had a kid hit on 21st Street and killed. So, we need transportation in Licking County. I don't think you disagree with me that the problems are there. What we do not agree on is the cause or solutions to these problems. I believe that nurturing the people in our community is just as important as developing commerce. I also believe it takes a community to help people develop their potential and provide support when they need it using tax payer money for human development is just as important maybe even more than using taxpayer dollars to support business development. During the recent election progressives who wanted to use taxpayer dollars to support and nurture humans were accused of being socialist, communist, promoting a welfare state. Those who want to use taxpayer dollars to promote and support corporations are considered good free market capitalists. I have a big problem with that characterization, I also see our national and state priorities as totally out of balance. I am going to keep coming back here to talk with you. You can count on seeing me at other public meetings. I totally support the poor peoples' campaign movement for a moral revival where the needs of this countries people, especially the poor and low wealth people are taken seriously and we work to address those problems. I'm not a socialist, I just want my taxes spent in ways that are consistent with my values. I will keep coming here to advocate for decent and affordable housing, reliable and affordable transportation systems, a low barrier shelter for the unsheltered, mental health and recovery resources for those who struggle with addiction and mental illness. And as far as the new development of housing that kids would go to Granville schools but live in Newark tax district and so forth, I really believe that we don't need more high end real estate housing, we need housing that is affordable for working class families. I also think it's unfair to the Granville system. My daughter teaches for Granville and I have grandchildren that go to Granville and to put the burden on them to pass a tax levy to fund a new school which they are going to have to do if they have more kids is unfair. I also think that these high end developments tend to increase segregation, not only racial segregation but income segregation.

Mr. Blake – Earlier when Clerk Phelps was giving her comments you said that you would allow a question?

President Ellington – I would.

Mr. Blake – I understand that her and her investigators are on the call and I don't want to assume that everyone had a chance to read that completion of their investigation. My question

to the investigator is, there were 3 names of former employees given to them and I just wanted to hear what their experience was when interviewing those three former employees. **Zach West – lead investigator,** We contacted all three of the former employees, two of them declined our request to be interviewed and the third we spoke to late last week. She was very forthcoming with us, was a bit surprised to be contacted. She had not spoken with Councilman Marmie or anyone else and was not sure how her name had become associated except that she thought it might have been through a mutual acquaintance. She did answer our questions, she was cooperative and again, as we say in our report, she denied that there was any hostile work environment because she was not a member of a protected class.

Mr. Blake – Thank you Mr. West, I just wanted to get an understanding that this all originated from 3 former employees and you weren't able to talk to 2 others. I feel like we have to have an understanding that this scenario is very irregular. Typically is there's a situation with an employee they would go to their supervisor and then to the department head, there's a chain of action that typically happens when there are allegations of harassment or work place situations. In this regard, you had former city employees go to a member of council and then the Personnel Committee has sent forward to us a Resolution to take tax payer dollars to continue an investigation. This Resolution currently before us doesn't have a maximum limit amount that we would spend. It has a minimum amount of \$10,000. But there is no maximum limit and there is no deadline as to when this investigation will be completed per this resolution. Is this to happen in the next 30 days or 60 days, how long is this investigation within Resolution 20-88 going to occur. This is a very irregular situation, it's a situation I don't believe is appropriate for council to be taking and I would urge members to vote no on this resolution. Mr. Marmie - I have a couple points of clarification. Mr. West indicated that he contacted three employees. I believe it was three employees that were listed on notes that I had taken. The names of those three employees were not the employees that I spoke to, those were the names of three employees provided by someone else that indicated I should speak to those three. The individuals that spoke to me, their names were on there, their full names weren't. Mr. West never contacted me other than asking for my notes. He did not ask which employees I spoke to. Another thing that I'm hearing is spending of taxpayer dollars. That's what the Clerk is doing now with her investigation, she is spending taxpayer dollars. In addition, she indicated that she made swift moves as soon as there were allegations to take action. She did not. That was not done until this legislation was prepared and going forward to city council. The city council is doing what was recommended by the HR Department. He gave three recommendations on what council should do. One was to do nothing due to the allegations, two was to let him investigate in which he indicated that he didn't have the capacity and then three he said to hire outside council. That is the three things the HR Director said we should do. The council decided to move forward with an independent investigation. I support that action. That way we're investigating something that will protect employees. So that is why I am in

support of this legislation Motion passed 8-2, with Mr. Blake and Mr. Fennell voting against.

COMMENTS FROM CITIZENS

I would like to have some answers to the questions, although this is not a time for debate, but as to how long this is going to last. When do they expect expedite, if you will, this investigation. How long will it take? Maybe the HR Director will be able to answer those questions for me or maybe Councilman Marmie might want to share with me the information if he's in that charge. I also want to thank Councilmen Blake and Fennell for seeing the report for what it was, true and honest, thorough,

as thorough as it could be given there was not complete disclosure of information, or so it seems. I also want to wish everybody a very Merry Christmas. It's been a difficult year for everyone, our office particularly in the courts, but we have perservered through all of those adversities and have remained open and been able to service the people through access to justice. With that said, I do wish everyone a very Merry Christmas, I hope your families stay healthy and I hope the new year is better than what we ended it with.

He did a records request in which he was requesting a presentation from the YMCA. That was provided to me so therefore I did not have any information to provide to him. Just to kind of set the record straight on that, I was not ignoring his request for information I just did not have any. The YMCA and the city administration was in possession of all the information. The next thing I want to discuss, I gave full disclosure, when asked to present my notes I presented all my notes to the firm doing the investigation. I provided answers, full detailed answers to the HR Department. I was informed the notes he took during my conversation were provided to the firm. I disclosed everybody that was spoken to. I don't know where this lack of full disclosure comes from, but I gave full disclosure. I did not deny any information, when asked to provide my notes I provided them right away, the same day and all the information that was on there. Just to set that straight and make sure that's out there. I too, Dee, had the great fortune of talking to the third grade class at Blessed Sacrament. They had some great questions and I was able to provide them a lot of information. They asked some though ones. They asked what I like best about my job on City Council, they asked details about what exactly we vote on. It was a great half hour. We had to limit it due to COVID. They're well educated which I am very optimistic about our future because the third grade teacher, Mrs. Chapman, she provided all the levels of the different branches, Judicial, Executive and Legislative. They knew some of the information when I started presenting they were asking questions, they were spot on so, I'm

very happy and optimistic about our future and what Mrs. Chapman is doing for them. Lastly, I just want to wish everyone a very Merry Christmas and a Happy New Year. I think I can sum up 2020 by saying we made the best of what we had. Hopefully there are still some positives everyone can be optimistic about during these trying times. Moving forward into 2021 I hope we take what we learned in 2020, make improvements for 2021 and do the best to do that in a safe manner in which everybody can get through this pandemic, hopefully we can get back to some normalcy, however, normal is a new normal. I think 2021 can be a fantastic year, we can show exactly what we're made of as citizens of the United States and making sure we're doing the right things.

Mr. Rath – One good thing about going last is everybody's already said everything, so I'll say ditto to what everyone has already said. I'll start out by calling a Service Committee meeting for January 4th. No idea if something will be going on them=n, but none the less we'll call a meeting. I did want to say thank you to Dave Rhodes for the additional stop light on West main and Terrace. To be guite honest with you it's pretty unobtrusive, I hardly notice it myself and it's fairly close to my house, but the residents on North and South Terrace appreciate that very much. Pulling out of Terrace onto West Main Street, especially if you're making a left turn, without a traffic light was very difficult. I also wanted to say thank you very much to Licking Memorial Health Systems, they sponsored that light. It was deemed justified by the increased traffic on West Main which was in part a result of Licking Memorial's expansion at the hospital and on Tamarack, so I appreciate them stepping up to the plate and taking care of that. I am getting a lot of emails about the zoning change on River Road. There's a lot of disinformation out there as well. I will let you know that the property there currently is already zoned residential so there is going to be housing there and there is nothing that can be done to change that. There is some zoning changes going on that make changes to that zoning to allow for about 180 apartment units. I would encourage everybody to get as much information as you can about those apartment units. When you hear apartments you automatically have a vision in your mind about what you think they are. What you think they will look like and what you think they will do to your neighborhood. I can assure you that is not what these are and it is not going to do what it is you think it is going to do. None the less there's a Planning Commission Meeting coming up. There are Facebook pages and Next Door pages dedicated to this and I'll make sure that we post access to that meeting and that is a Public Hearing Meeting and I am almost absolutely positive that it will be done by Zoom and after that there will be another Public Hearing at Council which will probably be in the same format as what you're seeing tonight. You have an opportunity to speak at both of those, so I would encourage you to do that as well. When citizens are emailing me, please be sure to include your address so I do know where you live. I wish everyone a very Merry Christmas and happy New Year. It's ironic that on the shortest day of the year, the longest night of the year, it's also the night that the Christmas Star appears and our skies have cleared so if you get an opportunity to take a look outside it's pretty spectacular.

President Ellington – I would just like to take a second to thank Law Director Sassen, our Mayor, Spencer and actually all of council for hanging in there during these meetings. I know it's been a tough year, everybody has stepped up and done a great job and I certainly appreciate all of council hanging in there and being able to put these meetings one because it certainly has been a challenge, but thank all of you for showing up and doing your part. Our next meeting will be January 4th, 5:45pm for Committees and 7:00pm for council. I'd like to thank all of our city employees for everything they've done this year, again it's been a trying time and they've just done a great job. So, thanks to all of our employees who go out there every day and to do their job. Let me add Merry Christmas and Happy New Year to everyone. I guess I would be remiss if I didn't say "Go Bucks" and we'll see you all next year.
