Mr. Fennell- I would like to say thank you to the Chief and the Fire Department for all the work they are doing. It is very encouraging to hear about all the collaboration that is happening with the Fire Department and Police Department.

Mr. Fraizer- I would like to thank Jeff Hotchkiss for coming to the HHCA meeting and speaking about the Parks Department all the work they have been doing over the last few years including the project that they are planning for North St Park. At the chicken noodle dinner we had the largest fundraiser that we have ever had for the HHCA, we raised \$4,000.00 prior to expenses. The HHCA has set aside \$2,000.00 to put in as additional funding for the North Street Park. I would like to thank the Fire Chief the Fire Department and the safety forces for the great job they do every day. I want to thank the Street Department and the Service Department for the work that they are doing on the roads with this crazy weather that we keep having. Congratulated the Newark boy basketball team on their championship and called for an Economic Development Committee meeting for Monday March 4th.
