17-32 AN ORDINANCE AMENDING CHAPTER 1234.02 OF THE CODIFIED ORDINANCES OF THE CITY OF NEWARK, OHIO RELATIVE TO THE RESIDENCY REQUIREMENT OF MEMBERS OF THE BOARD OF ZONING ADJUSTMENT/APPEALS Motion to adopt Ordinance 17-32 by Mr. Path

Motion to adopt Ordinance 17-32 by Mr. Rath

Director Sassen- I failed to mention to you Mr. Rath that because the emergency clause is not in there now and I know you want to make an amendment to add that you will need to make a motion to waive the two day reading rule first. **Motion by Mr. Rath to waive the two day reading rule, second by Mr. Marmie**

Mr. Rath- I want to waive the two day reading rule because I want to then make a motion to amend to add the emergency clause.

Motion passed by a vote of 10-0.

Motion by Mr. Rath to adopt Ordinance 17-32, second by Mr. Fraizer

Motion to amend Ordinance 17-32 by Mr. Rath, second by Mr. Lang

Mr. Rath- I would like to amend it to 17-32 A, there are three changes; one is changing the term from 5 years to 4 years to be consistent with the Charter, second change is addressing section 1234.02 stating members each of whom is either the owner of real property or the owner or operator of a business within the city of Newark and I would like to also like to add the emergency clause in order for this to be passed prior to the next scheduled meeting of the Board of Zoning Adjustments.

Director Sassen- there is a clarification regarding what is before you as Ordinance 17-32 A, in section 1234.02 where it mentions members each of whom is either the owner of real property or the owner or operator of a business within the city of Newark I had crossed out the words citizens of Newark that should read or a citizen of Newark. Committee amended it so that it can't be anyone it has to be a citizen of Newark a business owner or operator in Newark. I should have taken out the strike through of citizens of Newark.

Mr. Rath- we can open that up for discussion because during committee I don't believe we made the stipulation they had to be a citizen of Newark.

Director Sassen- that is why the word or is there. It means you can either be a citizen of Newark or a business owner or operator in Newark.

Mr. Rath- like I said I would like to open that up for conversation, I personally have no problem with that.

Mrs. Floyd- if it doesn't say that the way it reads you either has to be an owner or operator of a business in Newark. **Mr. Rath**- or own property

Mrs. Floyd- but it doesn't say a citizen that possibly rents and I think we are saying you can be on the board just by being a citizen of Newark.

Mr. Marmie- that is what I was going to say, if someone id renting a house, condo or apartment it would exclude those individuals even though they are citizens of Newark and voters in Newark.

Mr. Fraizer- can we put resident instead of citizen?

Mr. Fraizer- what is the definition of citizen?

Director Sassen- we're splitting hairs

Mr. Fraizer- wouldn't it be clearer if we put or resident instead of citizen because you'd have to get into what the definition of what a citizen is?

Director Sassen- I think that you're really splitting hairs because then you'd have to get into the definition of what a resident is. It is a distinction without a difference.

Mr. Fraizer- I would prefer the resident piece instead of citizen

Mr. Marmie- I could actually argue the fact that I am a resident of the City of Newark but I am not a citizen of Newark because if my residency is in Zanesville but I reside at OSU campus because I am attending school there then I am in fact differentiating that I am a resident but I'm not a citizen of Newark.

Mr. Rath- if there is no more discussion I will call to question.

Motion to call to question by Mr. Rath, second by Mrs. Floyd

Motion passed by a vote of 9-1.

Director Sassen- can I ask what the question is?

President Ellington- I believe it is to vote on it.

Mr. Marmie- he didn't make it clear whether he was voting on it.

President Ellington- I thought he did, tell us what the amendments are.

Mr. Rath- the amendment is to declare it an emergency, change the term from 5 years to 4 and to change the phrase to include members each of whom is either the owner of real property or the owner or operator of a business within the city of Newark or a citizen of Newark appointed by the Mayor.

Motion to amend by Mr. Rath, second by Mrs. Floyd

Mr. Cost- what about the change of the name of Adjustment instead of Appeals

Mr. Rath- that's not an amendment it is in the original legislation.

Mr. Cost- we have appeals crossed out and adjustment in it's' place so from my point of view we are changing the name. **Director Sassen**- that's not part of the amendment that was contained in 17-32 originally. The amendment is what is before you in 17-32-A. Mr. Rath's motion is to substitute 17-32 for 17-32 A with the additional amendment to correct my error to include the words or a citizen of Newark in section 1324.02.

Motion to amend passed by a vote of 10-0.

Motion to adopt Ordinance 17-32 A as amended passed by a vote of 10-0.

Mr. Marmie- there are procedures for abstaining, it is mentioned in caucus and we always separate that out so you can vote on the other stuff.

Motion by Mr. Marmie to amend and separate out sections 2 into a separate piece of legislation, second by Mrs. Floyd

Motion to amend passed by a vote of 10.

Director Sassen- there is actually five sections. It should be 1, 3, 4 and 5 voted on.

Motion passed to adopt section 1, 3, 4 and 5 of Resolution 17-50 by a vote of 10-0.

Motion to adopt section 2 of Resolution 17-50 by Mr. Marmie, second by Mrs. Floyd Ms. Hall- I just don't feel as though I should be voting on this due to my involvement with the grant. Motion passed by a vote of 9-0-1 (Ms. Hall abstaining)
