## **MISCELLANEOUS**

Mr. Fraizer- I guess new technology really excites me and 16-43 is the new server we are getting. When we invest in new technology to replace out dated technology to better prepare for the future I kind of jumped the gun on that one. There was a spring clean-up on Saturday. It did rain but five of us went out and cleaned up the Historical Hudson area from Channel to North Street picking up trash. Trash and littering is a huge problem in our community. All it takes is concerned individuals to go out there and try to make a difference and to be that difference in the community. I'd like to go visit your pub and see if I can pick up some trash to do my small part to make our community a better place. If anyone has been to the Master Gardeners plant sale it is great. You can get \$5.00 plants and they are some of the best plants you will ever have. That is at 473 Hudson Ave. It really takes us all making a difference to make our community better. If we had 47,000 people picking up trash and 47,000 people trying to make the community better that is really what it is going to take and what we should strive for. Hopefully we can all make the difference that we want to see. Ms. Hall- I would like to thank Mayor Hall, our Service Director David Rhodes, our Safety Director Bill Spurgeon, Chad Brown and Kristen Reed of the Licking County Health Department and our Property Maintenance Department for their immediate support with two situations in the first ward. One was a railroad car full of trash left in Little Texas that you could smell all the way to East Main Street. The other was a vacant house that had trash in the backyard. We had some residents really upset about this. Typically when a resident calls me with a concern I tell them that these people are really busy I can't get back to you until this afternoon or 2-3 days but everyone jumped on this and got things fixed very quickly. I really appreciate that and the residents wanted me to thank you as well.

**Mr. Johnson**- I want to thank Ms. Kittle for her comments towards the Council and we all agree that we would like to see more participation all the way around, here in Council and in the city.

**Mr. Rath**- thanked Mrs. Kittle as well for the compliment and for sharing her concerns because if you come to us and tell us we can't do anything to help. He called a Service Committee meeting.

**Mr. Blake**- I wanted to remind members of Council and members of the audience that there is a raffle going on for Officer Todd Brunton. You can purchase tickets to help with that raffle and the winning tickets will be announced Sunday May 15<sup>th</sup> at the Red Oak Pub where there is a fundraiser going on to help with his treatments. The next words that I want to say are to Kay because I think sometimes Director Spurgeon and his staff do a wonderful job as Dee has explained here and sometimes they do get booked up or behind because the day that we went down and took pictures of that property was April 4<sup>th</sup>. I sent an email to Director Spurgeon, Joe Paul and George Carter the same day because I remember when we were down there the resident wasn't too happy that we were there doing that but we wanted to do that and report the issue. Hopefully Director Spurgeon will work with you to get some resolution to that area.

Mrs. Floyd- called a Finance Committee meeting for Mr. Marmie. The Final Friday that was this past Friday turned out to be really successfully considering how chilly it was and by the end of the time they had sold all the tickets for the Chocolate Walk. You could get chocolate from 31 different places. The next Final Friday is on May 27<sup>th</sup> it is the food truck event on Walnut Street; it is also the same night as the opening of the Market Plaza. It should be exciting downtown Newark and really good for the community. This weekend is the fan fest. There is a brochure up in the office that tells what it is all about. It is May 6<sup>th</sup> through the 8<sup>th</sup>. Basically it is a series of things dealing with film, music and art. Most of the events this year are at The Works. They have artists, vendors, art shows, live music and film screening that is going to be at the Library. They have hands on art demonstrations that people can be involved in. There is a party at The Works on May 6<sup>th</sup>. There are a couple of big shows coming up in June. Sticks and Stones which has been around for 50 years will be performing June 11<sup>th</sup> and Three Dog Night on June 24<sup>th</sup>. We have a gem in this community and we need to keep it.
