He asked that the Mayor do a proclamation to recognize Donna Gibson for her hard work and dedication to working with addicts.

MISCELLANEOUS

Mr. Marmie- regarding 15-35 with it coming back to Council, I am in unchartered waters. It has never occurred where we have gotten it back and been a part of the negotiation process with the contract so I am curious as to how we are going to do that because usually negotiations are done in private but yet we are a public entity and we have public meetings so if they have to try to negotiate and come to us how can they discuss with us or with the public what that is because then it could be in violation of the negotiation? Will we go into executive session? Is that something that we would be allowed to do, authorized to do or should do? This is unchartered water we have never been a part of the process. I would like to know that at some point or another. I really do appreciate and applaud the folks who came down for 15-40 especially the children. I am going to speak on what has happened in the past. We have turned down so many resolutions of support because we have told folks that we don't do resolutions of support unless it has to do with a need to obtain financing or something along those lines. So if we are starting a new precedence what are the new rules and what are we going to allow and not allow as far as resolutions of support because we have not allowed them in the past. That is another thing that I would like to know going forward.

Mr. Blake- I want to echo what Paul Moran was discussing. I thought that the Bridges out of Poverty event last Thursday was very moving. Donna Gibson who is an employee of Mental Health America deals with several other agencies in our community dealing with substances abuse, mental health issues and returning citizens. Former convicts who have finished their sentencing and now are trying to become productive citizens in our community. It is a very good program and the work that's occurring there should be applauded because mental health issues and addiction is sort of the hidden epidemic that is occurring in our city and it is happening in every part of our city. This Saturday Mound City is starting off their opening day. He called for a Finance Committee meeting also.

Mrs. Floyd- this Thursday is the National Day of Prayer. It starts at 12:20. Blessed Sacrament and St Francis come and sings a few songs. The last two or three years the First Presbyterian Church has sponsored the community round tables.

These are meetings held at 12:00 and lunch is provided. You can just donate a little bit of money for the food if you like. They are the first Wednesday in June, July and August. In June the Mayor is going to speak.

Mr. Guthrie- he mentioned Linda Lignum from our community who he thinks has become a rising star in the field of art. Her husband Steve used to come to City Council meetings an awful lot and was a good advocate for our community. They have retired to Florida and Linda took up art and has pieces in galleries all over Florida and pieces in Roscoe Village right now. I guess I am a little biased to her she did a magnificent portrait of my granddaughter. She is a magnificent artist in the caliber of Dee Hall.

President Ellington- Mr. Marmie on 15-40 that was my call. I allowed that to happen basically because they felt they needed Council's support to get their World Heritage site recognition. I know we have been strict on that but that is why I allowed it. I am not sure that we are going to change the policy much. If it is something that would probably help the city I guess I am going to allow it again. I would be the one to be upset at on that one.

Next Monday the 11th we have Committee meeting and then Monday the 18th is Council. Thank you again for your attendance and helping us get through this meeting.
