ADMINISTRATION

Director Spurgeon- as we all know our Mayor has a commitment to public safety and to meet that initiative we have recently appointed one police officer and we will hire another police officer this Friday at 10:30 in Council Chambers, I invite all of you to attend. We are also going to ask the Fire Department for a name to swear in one more firefighter. He

wanted to publicly recognize they had a member retire last Friday. He said although he doesn't normally do this he was a great friend and mentor when he was a new firefighter. As he rose through the ranks he had an opportunity to command him. The fact that he will come down here and spend his free time to serve the City recording these proceedings, he wanted to recognize Jim Amore.

MISCELLANEOUS

Mayor Hall- our local CIC, Community Improvement Corporation Newark Development Partners is a partnership with the Chamber of Commerce. They have hired their new Executive Director, Fred Ernest(who then stood up for recognition) he took charge in that role a week ago today and he is out walking the streets, creating good relationships and we will hopefully have good economic development in the area as a result of.

He asked for everyone to have patience this summer with the construction work that has started. One example would be Granville Rd and County Club Dr, while most people would think that project is completed it's not, even on the southern end. The timing of the lights isn't even on sensors yet. Typically through the project we contract out the work obviously, ODOT is overseeing that. A signal person will be brought in and they will set the signals at Londondale. They will be putting in crosswalks at that point then hook up the motion sensor eyes at Country Club and Granville. They were great to get that second coat of asphalt in early before winter, the asphalt plant opened today so you will see projects improve as we go through the summer.

Mr. Guthrie- thanked the Administration, Director Rhodes in particular, for the effort that was made on Oakwood Ave. The light is on constant flash and he thinks it is a much safer situation than removing it and putting stop signs in there. He said he knew the Administration was being pushed from a couple of different directions and he is grateful they made the decision that they did. He told the Mayor that he was glad to hear that he was forming a group considering the Property Maintenance Code; he is hoping that there will be some representation from Council there. A couple of things that he hopes they look at are: one in particular is the issue of trash removal and whether or not it is an option. He knew this had to be deferred because out of respect for the landlords who have to make adjustments in leases because it does have a cost to it, shifting the responsibility of trash removal on to landlords. He would like to hear from the Property Maintenance staff on that particular subject. The other issue was the contract with the Fair Housing operation; he said he knew it might take a little while because we are under contract. We could see if there is any merit to bringing Fair Housing to City Hall and putting it in Property Maintenance Department. It would certain merit looking into it according to Mr. Guthrie, he suggested maybe training someone in Property Maintenance on Fair Housing issues, and it could bring that revenue back into the City. He said he had a couple more ideas but that he would submit them to the group. **Mr. Houdeshell**- he said it was good to be back and thanked everyone for the well wishes.

Mrs. Loomis- 100 Plus Women Who Care meet again tomorrow at 7:00, those ladies who are considering going they are asking for a toiletry which will be donated to the YES Club. Thanked Mayor Hall for taking the Ad Hoc Committee, citizens and last Mondays' Committee meeting seriously. Ad Hoc has brought up all those things Mr. Guthrie said, she appreciates him looking into that.

Mr. Marmie- called for a Finance Committee meeting.

Mr. Rath- called for a Service Committee meeting. He told the Mayor that he also appreciated him bringing up the opportunity to start a committee to look over the Property Maintenance Code and he said he would very much like to be the Council representative on that. He gave his condolences to the people in Boston.

Ms. Stare- commented on the tragedy that occurred in Boston and asked everyone to keep them in their thoughts and prayers.

Mrs. Floyd- thanked Jim Amore for his service to the City; he also helps Historic Hudson Community Association which she appreciates. She welcomed Fred Ernest; she thinks that it will be a good addition to our City and hopes that we can get a lot accomplished through him. She thanked Director Spurgeon and Director Rhodes who have helped her a lot with several projects in her Ward that have some serious issues, some of which are still being worked on. She mentioned that there is several neighborhood block watch groups are working and trying to deal with some of the issues that affect the City. Concerning Property Maintenance she thought that a lot of good things came out of the meeting last week, she said she thought that everybody left feeling like they got their message heard. She was glad that we are looking at Property Maintenance and stated she has a few ideas of things she would like to see done. She also stated she would like to be considered to be in that committee and she would certainly attend the meetings. She thought that it was important to show the citizens that we care about housing in Newark. We want safe housing and we need to do it in a practical way that we can actually see some results.

Mr. Frost- he said it was probably safe to say that everybody cares about safe housing in Newark but he was glad that the Mayor focused on safety forces. The Police Department and Fire Department are the essential things, then the streets. With regards to Property Maintenance he thought that Director Spurgeon did a great job introducing legislation that won't cost money and will allow us to hopefully resolve some of the problems that we are having, i.e. the trash problem Mr. Guthrie was talking about and if it works maybe it wouldn't be good to change the Property Maintenance Code. Now that we are getting back up to speed with regards to the Police Department and Fire Department, he thought that Property Maintenance was something to start looking at.

ADJOURNMENT- Being no further business to discuss a motion was made by Mrs. Loomis to adjourn, second by Mr. Rath. Motion was carried with acclamation.
