William Butcher- 129 W Main St, discussed that he would like to see a new Fire station go on the vacant lot on W Main St.

Tonya Cooper- 33 N 5th St, she was representing the Western Ave community garden that opened in April. She was encouraging City Council to come and visit the garden. She hoped to see more vacant lots in the City be utilized by the Community Garden organization.

Mary Jean Bell- 661 Maple Ave, she is a part of the community garden and has a plot on 6th St. She is requesting that one or more of the lots on Elmwood Ave where houses are scheduled to be demolished be considered for the Community Garden to utilize.
