1. Ordinance No. 19-02 an ordinance amending ordinances passed on December 3, 2018 providing for the issuance of not to exceed \$2,000,000 of bond anticipation note in anticipation of the issuance of bonds for the purpose of paying the cost of buckeye corridor storm water plan improvements, not to exceed \$1,000,000 of bond anticipation notes in anticipation of the issuance of bonds for the purpose of paying the cost of store in anticipation notes in anticipation of the issuance of bonds for the purpose of paying the cost of water system improvements, and declaring an emergency was considered.

Steve Johnson, City Auditor- there was an interest rate change which causes us to heave to redo the legislation. This is basically the same legislation that was passed back in December just as a different rate of interest.

Mr. Fraizer- what is the interest rate change? From what to what?
Steve Johnson- it changed from 3% which I think is just boiler point language to the actual rate of 4.25%. It is a little bit higher because there was an interest rate change and this note is only for a 90 day period rather than 365.
