We wish to report:

1. **Resolution No. 15-10** authorizing and directing the Mayor of the City of Newark to submit an application to the Ohio Department of Public Safety for an award of fiscal year 2015-2016 funding under the Ohio EMS training and equipment grant program was considered.

Barbara Gilkes- this is our annual application for our supply grant. Motion by Mr. Marmie to send to full Council, second Mr. Bubb Motion passed by a vote of 5-0.

2. **Resolution No. 15-11** appropriating monies for the municipal corporation was considered.

Section 1. A request for an appropriation of the unappropriated balance of the 298, ODNR Fund, in the amount of \$3,801.00

Barbara Gilkes- the city was fortunate to get a grant from the Ohio Department of Natural Resources. We need to appropriate the funds and we will be reimbursed for 75% of the total grant. The monies will be used to purchase some ADA playground equipment.

3. **Resolution No. 15-12** appropriating monies for the municipal corporation was considered.

4. **Resolution No. 15-13** authorizing and directing the Mayor of the City of Newark to apply for financial support from the State of Ohio 2015 Natureworks grant was considered.

Barbara Gilkes- this is a new application that is due May 1, 2015. Right now we are looking at the bike path and the cemetery as the areas that we will concentrate on with this grant application. The Citizens Advisory Committee will be discussing both ideas in the upcoming months.

Barbara Gilkes- it can come from in-kind, cash or a combination

Mr. Marmie- do we have a plan yet?

Mr. Marmie- is it going to come from Capital Improvements or General Fund? **Barbara Gilkes-** it is possible that it could come from Capital Improvements however with these Nature Works grants we can count in-kind labor. Anytime the Parks and Cemetery staff does work I can cost out their time. I always try to do that. We usually end up doing a combination. It is not set in stone but it will be Capital Improvement and in-kind.

Director Rhodes- we have already received our first donation of \$5,000.00 that is also going towards it.
