 Resolution No. 21-79 A RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO EXECUTE A CONTRACT FOR REIMBURSEMENT OF LEGAL REPRESENTATION OF INDIGENT PERSONS FOR CALENDAR YEAR 2022 WITH THE LICKING COUNTY BOARD OF COMMISSIONERS FOR THE CITY OF NEWARK, LICKING COUNTY, OHIO AND DECLARING AN EMERGENCY.

Tricia Moo9re, Law Director – This is the same as a Resolution that we asked to be passed last time, there was a change in the law and that happened this year unbeknownst to us and the county so, we have now given notice to Granville Twp. Trustees and so we want to make sure all the technicalities are met, so this is just the same resolution as before. The reason for the emergency is it needs to be done before the calendar year ends.

Mr. Barker – Originally this legislation was more than just Granville Twp.

Ms. Moore – We are doing legislation for those, but Granville Twp. was the biggest group of individuals that would be affected so we wanted to get them through.

Mr. Barker – So we'll be seeing other legislation for the other entities to conform our boundaries with them as well.

Ms. Moore – Correct.

Mayor Hall – When the County brought this to us it was about Granville Twp. And there are some taxing issues there, they could pay duplicate taxes, some issues if we don't straighten it out. When we got everyone together then we said let's grab it all, all the other townships. They don't have that issue in their areas as much as Granville Twp., so that was the focus, as the Law Director said, to get that first so their books are straight moving forward for taxes.

Mr. Marmie - This won't need to be voted on, we're bringing this up on Rule 11 tonight, it has

to be passed tonight, so this is just for discussion purposes I believe.
