**Brandon Fox, Water Administrator** – Good evening. Just want to take a minute to give a shout out to all of our water and sewer staff. You may not know it tonight, it's 60 degrees, but the last month has been pretty difficult with the cold temperatures. It's been a few years since we've had cold temperatures like this, so shout out to all of our staff that's out there doing the duty 24-7. But especially to our water distribution and sewer maintenance crews. We had 16 water breaks over the last month since like January 4th or something like that. So, a lot of hours spent after hours, and then they come in and we have another break during the day that they're expected to respond to. So, doing a great job. Just wanted to recognize all those staff. Thank you to everybody out there.

# Tricia Moore, Law Director – I pass, thank you.

**Mayor Hall** - Yes, Joyce Malainy, I would like to thank her for 15 years as superintendent of CTEC. She has recently retired, and congratulations go to Michelle Snow that has stepped up and works as the new superintendent of CTEC. That's obviously a great asset in our community. Second of all, under communications was some mention about Junior Achievement. I would encourage everyone to look into that and learn a little more about it. With ribbon cutting on Friday, we've probably worked for a couple years on this. There are eight Junior Achievement Associations in the state of Ohio. This is only the second location of what I would call a lab or a work center for the students in the entire state. It will service up to 20 counties, I believe. There is a city hall in there of a city called Newark. I want to thank all the companies that partnered. The fifth graders will come into the BizTown side, and the seventh graders will come into Finance Park on the other side. It's a great way to join our students and our youth into real life out there in the workforce. It's a great partnership with Newark City Schools, and obviously it's got 17,000 square feet out in the State Farm Building, so what a great use. And finally, on Friday, 650 people attended the 69th Annual Groundhog Breakfast out at OSU Newark. I want

to congratulate the chamber for putting on another great event, and thank you for everyone that attended. With that, I will pass.

**Mr. Rath** – First off, I'm looking forward to Friday afternoon, our first public event at the Arcade. We're going to have a market on Friday. I believe that starts around 4 o'clock, so I'm looking forward to that. I guess before I go any further, I want to welcome my wife to the chambers. Good to see you. I also attended the Groundhog Breakfast on Friday. Thank you for the invite, Mr. Mayor. I appreciate that. I also wanted to say congratulations to Scott Hayes for winning the Community Service Award. I want to call a Service Committee meeting for Tuesday, February 18th, and with that, I will pass.

Mr. Rine – Thank you, Mr. President. I'll pass tonight. Thank you.

**Ms. Bline** – Thank you, Mr. President. I, too, am looking forward to the Arcade opening. It's going to be very exciting. There are a lot of people who have been asking about it, so momentum is building. I'm very excited about that. Congratulations as well to Scott Hayes on winning that Community Service Award. I'd like to thank the residents who came out twice this weekend from 9 a.m. to 3:30 Saturday to give attention to an area that needed an upgrade, and so they worked on that, and then again on Sunday from 12:30 to 3:30. It was a very busy weekend, and amongst all that, I was very cognizant to notice the number of needles that were found, and the number was down 80 percent. Eighty percent on found needles. That's incredible, and that's a huge shout-out to our NPD, the law director, and prosecutor for standing firm on the law that needle distribution is a felony, and that boundary is making a huge difference in our community. I just want to thank, again, our fine folks in the Service Department for standing.

**Mr. Houser** – Thank you, Mr. President. I would just like to thank Brandon again for the work that all your team did on those water breaks. That's got to be a lot of pressure, and I really appreciate all your team has done on that. I also attended the Groundhog Breakfast. It was great to see everybody out there, and with that, I'll pass.

**Mr. Labutis** – Thank you, Mr. President. I also wanted to congratulate the Chamber on the Groundhog Breakfast. It's always a great event every year, and I always enjoy getting to go to that. I'm also looking forward to the Arcade opening on Friday. I think there's going to be a lot of neat shops that will be in there. I know some are still being built out and are still in that process, but it's going to be a fantastic facility, and it will draw attention to downtown as well. I'm also excited that 25-02 passed this evening. That's an area that has needed to be widened for quite some time. If you've ever tried to turn left on W. Church St. and have someone zoom around you on the right side, you know why that's there. So, I'm excited that work will begin later this year, and I'm happy for that. With that, I will pass.

**Mr. Marmie** – Thank you, Mr. President. I need to call a Finance Committee meeting for February the 18th. I want to just echo what the Mayor has indicated as far as the Junior Achievement with the BizTown. My children were fortunate enough to be able to go through BizTown, but they had to travel all the way over to Columbus. To have that in our backyard, it's just fantastic. It's a great experience for kids and adults alike because it takes some chaperones to help out with it. It teaches them a lot about how a city operates. Junior Achievement in other communities has been remarkable as far as just educating youth on some of the more common things like having a checking account and other items that aren't necessarily taught in the schools. I know that I've taught different insurance courses through Junior Achievement, and it is just a fantastic program to help educate our youth and to enhance the experience that they get in their regular education. I'm looking forward to that. I think it's going to be fantastic to be a part of our community. And then, finally, the Arcade. I, too, am excited about the first phase opening up on Friday. The Farmer's Market always draws some attraction, and to have a location during the wintertime where that's going to be housed is going to be fantastic for the downtown area. It will be a temporary thing as far as it will move back outdoors once the weather breaks. However, they're anticipating next winter, during the entire winter, having the Farmer's Market down there. There are other facilities that are going to be opening. It's probably going to only be a partial opening for most of the locations. There are additional ones that are going to be opening up in the spring. And then, finally, they believe that they should be at pretty much full capacity by the summertime. So, it's exciting for our downtown. Everything looks great downtown. I think things are feeling better downtown as far as the safety of our citizens. I believe that there's a lot of good things that are helping to stimulate economic development. I appreciate what the mayor, the administration, in collaboration with Newark Development Partners has done to bring this project to fruition. I think it's just going to be a huge asset for our community. Finally, I want to thank Brandon and his folks as far as the work that you have done and continue to do. Those breaks don't always just happen in the cold, but we do appreciate it when your folks are out there taking care of it. As well as, we appreciate our first responders who are here, police and fire. They're doing their job day in and day out in inclement weather. A lot of times, it just goes unnoticed because they're just doing their job. So, we really do appreciate it. We appreciate that the water is always running for us, and we really do appreciate what the first responders do as far as taking care of our citizens and the safety of our folks. And with that, I'll pass.

**Mr. Neely** – It's not tough enough to go after Doug Marmie, I get to go last tonight. So, I'll just say, ditto on the Arcade and the Water Department. Great job on both. So, with that, I'll pass. **President Harris** – Thank you. It's February, so that means it's Black History Month. As you guys know, every year I usually give some facts about black history. So, some fun facts for Licking County for Black History Month. Robert Weaver was the first African-American Newark city councilman, Licking County Municipal Court judge, and also council president. Eddie Mae Scott was the first African-American deputy sheriff in Licking County in 1962, and Chester Hart was the first African-American probation officer in Licking County in 1960.
