Steven Smith, 237 Violet Ct. - I'd like to ask that we keep in our thoughts the people that were lost in the horrific shooting in Minnesota in the last couple of days. As many people have said, this sort of political violence should not be tolerated in our society, nor any sort of political violence. It turned out in front of a car there on 2nd Street doing 35 mile an hour the other day. Somebody's going to get hurt and get killed. Don't want to see it. Also, I have complained about this before, Isabel Road, the parking on both sides. When the construction started, they left it that way to slow traffic down. Well, you better come up there and sit, because it hasn't slowed traffic down at all. And the one guy up there parks his trailer there and he holds his tractor around on and everything. It's been hit twice since then. Whoever hit it just backs out and goes on. So, I mean, let's look at this a little bit. I mean, it's a danger. Not only a danger to the people driving, but a danger for the little kids in that neighborhood. If they're crossing the street and there'd be one behind one of those cars, they're not going to see a car doing the speed down Isabel. Isabel's 25, and you see cars doing 35, 40, 45. If a little child gets hit with that, what are we going to do? We don't want to wait until it's too late. That's all I have. Thank you.

Steven Smith, 237 Violet Ct. - I've noticed throughout Ward 3 and some other areas there's a large number of poison hemlock plants growing along the roads. This apparently, I haven't seen it this bad for some time. Apparently, the growing season has been very good for those plants. Particularly noticed some plants on Reddington Road right across from the playground area where I see people walking frequently and right by the dog park where I occasionally see people actually relieving their dogs on that side of the road. I'm not sure who the owner is of that particular property. I did call in a notice to the property maintenance department on that. Driving around, I see poison hemlock all over the place in in the city. It's become a real problem this year.

Everybody kind of realizes that connected the Ohio River to Lake Erie and it went right through Newark here. Festivities on that Saturday begin at 10 a.m. It's at the Canal Market District and if anyone wants any more information, the Historical Society has worked pretty hard on that. They have a lot of activities for kids and recognize that bicentennial event. Thank you.

So just make a phone call. There's even a thing online that you can go in and just do a report as well. With that, I will pass.

Mr. Rath – I'll call a Service Committee meeting for July 7th and I'll have the bridge open on Cherry Valley Road and South Chalfant closed. With that, I'll pass.

Mr. Rine – Thank you, Mr. President. I'd like to thank the administration and YMCA for coming together and getting the Hollander pool open. We know the city has been waiting for that. So, thank you. With that, I'll pass.

Ms. Bline – Thank you, Mr. President. I'd like to thank the VFW for allowing me to come speak recently. It's an honor to hear the stories and the valor of these men and women. People think that bravery is on the battlefield, and it is, but bravery is in faithfulness, in the tedium of every day, just making sure that guns are working correctly, that bullets are counted. There's nothing glorious in that, but there's faithfulness. That's how we win, is faithfulness. I'd like to thank NPD. Some citizens have requested some services that were fulfilled recently, and I really appreciate that. I noted them to Deputy Chief

Brnjic so that those officers could be commended. We really appreciate NPD. They've been doing a great job. I'd like to thank the citizens on 13th Street. We've really been working that area, getting it renovated for the kids, because we're finding if you raise the bar on something, as someone said, you can stand up, but if you stand on someone else's shoulders, things tend to improve quicker. So, I want to thank those adults over there for leading that charge. Lindsey Brighton for helping during the Raccoon Creek and Licking River cleanup. That was a great time. It really was. A lot of people came out. We pulled a lot from those two areas, a lot of garbage. It was great to see kids playing in the water and just enjoying themselves. Kind of what used to be a long time ago. I want to thank all the citizens who spoke to me about the noise ordinance. I had a long talk with our law director, and we are going to chat about it. I'm so glad she's willing to look at this, because we haven't had one application for a variance since this whole thing started. Not one. It makes me wonder quite a few things, and along that line, there's some things that we need to think about. If indeed a variance were submitted and our good safety director said yay or nay on it, where would it be published for people to see so they would have a chance to respond? That's important, that people would have heads up. And then, to be sure again that the public would be notified, where would that show up? I know our websites, they're packed, but we would have to figure that out. Where would it go? Where would it go for people to see? I'm very grateful, again, for our police. They showed up, and we did some decibel meter readings. You know, that's a non-essential call. They could have been doing other things, but they came. Sometimes they couldn't come, because they did have essential calls. Therefore, the circle of service wasn't fulfilled. Not that it was anybody's fault, but they just couldn't come. So, there's some things, for my sake and for the opinion of some of our EMS and citizens, that we could shore up on this variance, just to make it more successful for everyone involved. Again, I appreciate the law director working with me on this. And, again, I thank everyone who came out these past two weekends. Thank you, sir.
