**Mr. Marmie** - The unappropriated balance of the General Fund is \$767,169.00 and the balance of the Budget Stabilization Fund is \$1,683,758.00.

Basically, the first part of this is to take it from Budget Stabilization, the second part it will go into the General Fund from there. It's appropriated from the General Fund into a construction account within the Service Department for future construction.
