We wish to report:

Mr. Marmie - The unappropriated balance of the General Fund is \$365,731.00 and the balance of the Budget Stabilization Fund is \$698,128.00.

1. **Resolution No. 25-06 Exp** APPROPRIATING MONIES FOR THE CURRENT EXPENSES OF THE MUNICIPAL CORPORATION

Section 1. There is hereby an appropriation of the unappropriated balance of the 231 Adult Probation Fund, in the amount of \$6,000.00 (For the purchase of transit passes)

Kevin Saad, Adult Probation Director - Good evening. This is in reference to our grant program. It won't cost the city any money. We've been purchasing these transit passes for our offenders since 2016. We didn't put it in this year's budget because we were trying to watch the budget to see if we might need the \$6,000 for something else. It looks like we don't. So, we're going to go ahead and make the purchase if you approve it.

2. **Resolution No. 25-07** A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF NEWARK TO APPLY FOR FINANCIAL SUPPORT FROM THE STATE OF OHIO 2025 URBAN FORESTRY GRANT.

Barbara Gilkes - This is a new grant that the Division of Parks would like to pursue. We will be reimbursed if we're successful. 100% of our costs for tree planting is the plan. Right now, they're trying to decide which areas to plant the trees.

Mr. Marmie - Do we go through the, I think, isn't it soil and water conservation that does things with trees as well? They sell trees and do all that?

Ms. Gilkes - Well, they may. I'm not aware of that. We're going to get an estimate for the grant application, and from what I understand, Chance is looking at getting an estimate from Albans. But if we are successful, we have to open it up for fair competition for the contract. Right now, we're in the planning stages, but we can have the vendor plant the trees as well, which would probably be the best route to go, simply because the Division of Parks, they're fairly stretched with all their other responsibilities, and I think it would come out better if we went that route.

Mr. Marmie - Doesn't soil and water conservation, aren't they an extension of the government in order to provide us guidance and a plan for forestry?

Ms. Gilkes - Well, they may be, but according to this grant, we have to follow certain guidelines as to what types of trees are going to be planted. We're not obligated to go through soil and water for the grant.

Mr. Marmie - But it's specific in the fact that there's already a plan for a forestry for improvement to have additional trees in the title.

Ms. Gilkes – Yes.

Mr. Marmie - Okay, very good. Thank you.
