We wish to report:

Mr. Marmie - The unappropriated balance of the General Fund is \$299,611.00 and the balance of the Budget Stabilization Fund is \$767,008.00.

1. **Resolution No. 25-32** A RESOLUTION APPROPRIATING MONIES FOR THE CURRENT EXPENSES OF THE MUNICIPAL CORPORATION.

Section 1. There is hereby an appropriation of the unappropriated balance of the 100 General Fund, in the amount of \$1,400.00 (Grant given to the Parks Dept for a purchase of equipment)

Section 2. There is hereby an appropriation of the unappropriated balance of the 673 Buckeye Corridor Storm Fund, in the amount of \$373,000.00 (River Road Culvert replacement and drainage work)

Brandon Fox, Water Administrator - Happy crazy weather day, whatever you want to call it. So, this is money that is trying to be allocated for the culvert out on River Road, right next to Park Trails. We currently have a project for River Road sewer, sanitary sewer, and this is going to be a change order for that project since the contractor is working the same general area. This money was on a 2019 bond that we had left over from some stormwater work out on the 40th Street waterline storm project out on the west side, and so this is money that's sitting in our account that can be used for stormwater projects, and so we're requesting to allocate that towards the culvert replacement.
