## We wish to report:

**Mr. Marmie** - The unappropriated balance of the General Fund is \$270,841.00 and the balance of the Budget Stabilization Fund is \$512,928.00.

**1. Resolution No. 25-47** A RESOLUTION APPROPRIATING MONIES FOR THE CURRENT EXPENSES OF THE MUNICIPAL CORPORATION
