Mr. Rath - Mr. Carter while I have you here this evening I would like to ask you specifically what is going on with Showman. It's an absolute disaster, it's about a block long. It's a debacle.

Mr. Carter - I am familiar with Showman Avenue, debacle might be the right word. This is property I've been working on several years, we've issued citations, we're talking several thousands of dollars issued for about 10 different parcels on that road. They encompass the entire west side of the road and one on the east side of the road. It's had zero effect on the citation effort. Approximately a month ago I met with our Law Team and we began the process of criminal charges against the owners of those properties. That's the current information I have for you on those properties they have been referred to the Law Directors office for criminal charges, I have not heard back from them yet on how that process is going.

Law Director Moore - I am aware of the Showman process, I will get you an update.
