26-20 AN ORDINANCE AMENDING THE POSITION CLASSIFICATION, PAY RANGE AND DEPARTMENT AUTHORIZATION TABLES OF THE CITY OF NEWARK, DEPARTMENT OF SERVICE, DIVISION OF WATER AND WASTEWATER BY ABOLISHING ONE WATER METER CUSTOMER REPRESENTATIVE POSITION CLASSIFICATION WHILE CREATING ONE WATER METER TECHNICIAN POSITION CLASSIFICATION AND SETTING THE COMPENSATION THEREFORE

26-23 AN ORDINANCE SETTING COMPENSATION AND STATING POLICY WITH RESPECT TO CHIEFS AND DEPUTY CHIEFS OF THE CITY OF NEWARK, OHIO; REPEALING ALL ORDINANCES AND RESOLUTIONS IN CONFLICT WITH THIS ORDINANCE; AND DECLARING AN EMERGENCY.

26-38 Exp A RESOLUTION APPROPRIATING MONIES FOR THE CURRENT EXPENSES OF THE MUNICIPAL CORPORATION.

26-40 A RESOLUTION AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE OF THE CITY OF NEWARK, OHIO, TO ENTER INTO CONTRACT WITHOUT COMPETITIVE BIDDING, SUBJECT TO THE APPROPRIATION OF FUNDS, FOR THE REPAIR OF MANHOLE AND SANITARY SEWER AND REHABILITATION OF THE LICKING RIVER AROUND SAID MANHOLE, AND DECLARING AN EMERGENCY.

26-42 A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF NEWARK, OHIO TO EXECUTE THE PATASKALA CORPORATE PARK JOINT ECONOMIC DEVELOPMENT DISTRICT CONTRACT AMENDMENT NO. 2 BY AND BETWEEN THE CITY OF NEWARK, OHIO, THE CITY OF PATASKALA, OHIO, AND HARRISON TOWNSHIP (LICKING COUNTY), OHIO AND DECLARING AN EMERGENCY
