The following legislation was adopted in June 2026 by the Newark City Council.

26-17 AN ORDINANCE VACATING PORTIONS OF WATER STREET, RIVER STREET, HILL STREET AND TWO SIXTEEN (16) FOOT WIDE ALLEYS AS SHOWN ON THE PLAT OF JAMES L. BIRKEY'S 1st ADDITION, AS RECORDED IN PLAT BOOK 2, PAGE 236 OF THE LICKING COUNTY PLAT RECORDS; SAID STREETS AND ALLEYS ARE LOCATED BETWEEN SPRING STREET AND THE LICKING RIVER.

26-31 A RESOLUTION AUTHORIZING THE CONVEYANCE OF CERTAIN REAL PROPERTY NOW OWNED BY THE CITY OF NEWARK, OHIO TO NEWARK DEVELOPMENT PARTNERS AS ITS AGENT FOR INDUSTRIAL, COMMERCIAL, DISTRIBUTION, AND RESEARCH

26-35 Exp A RESOLUTION APPROPRIATING MONIES FOR THE CURRENT EXPENSES OF THE MUNICIPAL CORPORATION.

26-33 A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF NEWARK TO SUBMIT AN APPLICATION TO THE OHIO ATTORNEY GENERAL FOR FEDERAL FISCAL YEAR 2026 SHINE A LIGHT ON DUMPERS GRANT.

26-34 A RESOLUTION APPROPRIATING MONIES FOR THE CURRENT EXPENSES OF THE MUNICIPAL CORPORATION.
