Director Saad- at the beginning of fiscal year 2014-2015 there were performance measures set for that particular grant cycle. We achieved at 100% on two of them and 90% on the other one. If we achieve at this level they will pay us in essence a reward for doing what we said we were going to do. The incentive for lower probation violations was \$48,500.00 and the incentive for lower the number of people returning to jail was \$39,000.00 and then the incentive for increasing our ORAS assessments was \$2,070.00. **Mr. Blake-** what is it you will do with these incentives?

**Director Saad-** we have to spend it according to ORC Section 51.49.30 and what that is Community Corrections Program and one of the sections is titled probation so we can spend the money towards anything in the Probation Department.

The biggest bulk of that money is for a dump truck they cost about \$100,000.00.

**Mr. Cost-** you said that one of the vehicles was a dump truck for \$100,000.00 what are the other two vehicles?

**Roger Loomis-** pick-up trucks for service vehicles. They are purchased off of the State purchasing plan so all of the bidding is done through the State.

Mr. Blake- what will happen to the old ones?

**Roger Loomis**- we have been selling them on Gov Deals. The dump truck will go on Gov Deals but the pick-up trucks we may trade those in.

3. **Resolution No. 15-60** authorizing and directing the Mayor of the City of Newark to prepare and submit an application to the United States Department of Justice, for fiscal year 2015, COPS Hiring Program was considered.

**Ms. Gilkes-** the city has decided that we are going to apply for two entry level officers through the COPS Hiring Program.

4. Ordinance No. 15-17 to provide for the issuance of \$6,600,000.00 of bond anticipation notes in anticipation of the issuance of bonds for the purpose of refunding outstanding bond anticipation notes previously issued for the purpose of paying the cost of capital improvements, including fire station 1 improvements (including demolition, professional design and property acquisition), city hall parking improvements, service complex construction improvements and south second street bridge repair, together with additional fire station 1 improvements (phase 1), additional funds for fire station improvements, and all necessary appurtenances thereto, and declaring an emergency was considered.

**Steve Johnson, City Auditor**- what you read his the history of this debt. We have a one year note that was approved by this committee about this time last year that allows for the construction of the fire station and three other capital projects. Since this was a one year note it needs to be renewed at this time. It is the intention of the city next year to issue a long term bond to replace this. It would be a more structured type of debt. I think that what we would do this time next year is issue two bonds. One bond for 5.5 million that just covers the fire station and the second one for 1.1 million to cover the other capital items that are involved here. I would like to do it that way to keep it clean since we have dedicated revenue from EMS billing paying for the fire station debt.
