COMMENTS FROM CITIZENS

William Butcher, 263 Union St- stated that the Courthouse lighting was beautiful.

David Greene, 1791 Olympic Ct- discussed changes in the economy such as "the electronic revolution" meaning technology replacing labor in many jobs. He stated that he has been told that the jobs that are available are low wage, part-time and temporary. The Bureau of Labor statistics considers someone employed if they work one or more hours a week that means the statistics which are defining who is unemployed and what is going on is belittle the magnitude of the problem. Many jobs that thought they would never be replaced by electronics are being that way. This electronic revolution is changing the nature of work and therefore changing the economy. He also discussed the increase in poverty despite the numbers of those employed and the transportation needs in the company. He stated that a 1/3 of the Licking County population is at or near the poverty level. He encouraged Council to not try to do the same things that they have been doing but start to address more seriously the needs of the community, not just to paved round about around City Hall but to people without enough food, not being able to pay for adequate shelter, no transportation and not having adequate paying jobs.

Mr. Guthrie- Mr. President before we get into the agenda I have a question. I apologize I was talking with Autumn about it. When we had our Rules Committee meeting my recollection was Doug that we voted for the legislation with the ethics training and we tabled the issue concerning the actual rule change until next week. However the training legislation is not on the agenda. Shame on me because I obviously missed it in the minutes. Do you remember Doug was it in the minutes that we voted it out?

Mr. Marmie- yes I thought that I saw it in the minutes

Clerk- that is my fault I didn't realize the legislation and the rule were two separate issues being voted on. I thought it was tabled until next week.

President Ellington- Mr. Sassen is there anything that we can do about that since it was not on the agenda and we made a mistake?

Law Director- I suppose with the consent of the majority and minority leader under rule 11 it could be brought up for a first reading tonight. It is a little creative interpretation of the rule but if Mr. Guthrie doesn't object.

COMMENTS FROM CITIZENS

William Butcher, 263 Union St- he asked how long it would be until Cherry Valley Road will be open.

Daniel Crawford, S 2nd St- What's in a name? More importantly, what's in a name that is supposed to represent a group of people? It has been asserted that affixing the label Bulldogs or Wildcats to a sports team or a school is equal to doing the same with respect to Redskins. If Redskins is offensive, then what about the other two names? Is it not logical to say that calling your team the Bulldogs is an insult to bulldogs? No, it is not logical to make such a comparison, because these labels have very different histories. In what sense can we say that an animal-based mascot is an affront to those animals? I know of no examples where the labels Bulldogs or Wildcats were used to disparage those creatures, and I'm willing to bet that none of you are able to think of any either. Let's get to the point here. A few weeks ago, a fellow citizen spoke up about how the use of Redskins as a mascot must come to an end. We've seen the backlash against political correctness for quite some time now. In some instances I'm in solid agreement that this pc movement has overstepped its bounds, but here is one area where the backlash is dead wrong. In case you need some background information to understand why, here it is. For example, in an educational textbook published and distributed in the late1800s in New England entitled A New Primary Geography (1886) -, young students were taught in pages 24 through 25 about five races of people, with the Red Race being associated with those people which our forefathers referred to as Indians. In case you make the mistake of concluding that the term is harmless even here, the textbook went on to say on page 26 that: "the various races of men differ greatly in regard to knowledge and manner of living. For this reason they

are sometimes divided into four classes: Savage, Barbarous, Half-Civilized, and Civilized." A little further it continues: "Savages are the lowest and most degraded class. The Indians and most of the negro tribes are savages. Savage and barbarous tribes are almost always engaged in war." Then, the book wraps up this portion of its racist indoctrination by reassuring its young superior-race readers that "almost all civilized people belong to the white race." We know that redskin wasn't just a derogatory label, but a violent one as well. In sharing an excerpt from an 1863 edition of one Minnesota newspaper, Baxter Holmes of Esquire points out at least one troubling use of the word: "The state reward for dead Indians has been increased to \$200 for every red-skin sent to Purgatory". Then, that same announcement followed up by noting that this reward was greater than the value of all extinguished Indians east of the Red River. There is some debate as to whether this particular advertisement for murder was calling for the scalps of Native Americans which wasn't an uncommon practice at the time, but the one thing that is clear here is that hate not an attempt to express or inject a sense of community pride motivated the use of redskin. How convenient of us mostly white citizens to stand here and proclaim that Redskin is a harmless label. How convenient indeed for us white men and women who've never experienced a legitimate threat to our collective existence or safety even as our forefathers did much to ensure the same for other so-called races. I'm not assuming that every fan or student calling themselves a Redskin is racist, but what they are celebrating is an icon of evil, plain and simple. Let's try an exercise, shall we? Many of us were raised with the notion that if you can't say it to someone's face then don't say it all, or if you can't do something out in the open, then it should not be done. I say, if you can't comfortably walk up to a random Native American and refer to this stranger as a Redskin, then you probably shouldn't use the term at all. Moreover, if you can't use the other skin terms equally, then that should say something about the level of decency attached to the word. Ask yourself, if you were starting from scratch, would you be in favor of naming Newark High School's team the Newark Redskins? Or, what about the Newark White skins, the Newark Yellow skins, the Newark Brown skins, or even the Newark Black skins? Of course you wouldn't dare think of choosing one of the latter four, because that would be obviously racist, right? So, how is Redskin any different? Perhaps Redskin is preferable because it seems to communicate something intimidating like the Wildcat and Bulldog mentioned earlier. Think about that for a second, while also remembering the afore referenced piece which claimed that Native American Redskin savages are almost always at war. Bear in mind that our white ancestors were taught to fear the Redskins, because of their perceived ruthlessness and brutality. Now, look at this situation from the opposite end. If you were a Native American citizen, would you be happy to pay taxes for and/or send your child to a school with a label that used this term? If not, then I think the answer is clear: the time to stop calling anyone a Redskin was yesterday.

Paul Moran, 63 N 4th St- stated five problems in Newark: housing, transportation, jobs, vacant commercial buildings and neglected city owned property.

Before the concert in front of the Midland the Newark High School choir sang Christmas carols for about a half of an hour and then when you went inside the Granville choir was on the balcony singing Christmas carols. It was a wonderful Christmas show. Next Friday the Midland is showing Polar Express. I think it is \$5.00 to go. Last year it was so crowded that they are doing assigned seats. There are fabulous things going on in Newark. I know it is a tough time for a lot of people and I know that we certainly have problems in our community but there are good things going on as well.

Mr. Guthrie- Mayor I am glad that you mentioned Skip. I know that I have mentioned something in the past about how he promoted in his own radio ads going to businesses out at Buckeye Lake that are really hurting because of the water

levels out there. I think that is awesome. He and his family made a very generous contribution to Karis's Cause and our mission to help families with children with childhood cancer. I appreciated the point that Dave Greene made earlier regarding industrial jobs and other jobs. One of the things that I am seeing because I am getting old as are a lot of my fellow getting old people, is they are working two and three jobs in their retirement years because that is just what it takes these days to go to keep going and subsidize their social security to the degree they ae allowed to do that. It is a shame they have to be penalized for making a little over \$15,000.00. Mr. Greene. Mr. Crawford and Mr. Moran in case I forget to say this at the next meeting I think that in a lot of ways you bring forth a level of consciousness that needs to come forward at these Council Meetings. Whether people agree with all of your positions or not I think that it is really important and I really admire you. Come next year when I am watching these things on my computer I am going to be hoping to see you all and listen to you. I'm glad that Carol brought up the Midland I went there a few weeks ago and saw Arlo Guthrie who I like to claim is my cousin and it was a fantastic concert. It was the 50th anniversary of Alice's restaurant. As we see these terrible, senseless murders that have taken place in the last two or three weeks in our country it reminds us again of our first responders. We can't say enough about the importance of these folks to our community. They are going in when other are coming out. We are lucky to have them and I have tried my very best to be an advocate for them.

Mr. Johnson- wished Mr. Rath a Happy Birthday. I think that we should really remember what December 7th has meant to our country. We need to remember what we are all about. It is important that we are strong Country. The Christmas concert was wonderful and we should be proud to have that opportunity. I asked him what his favorite locations were and he said that he never had a bad one and I even did two stints in Vietnam, because he is still alive. He said that he did what he needed to do and that this country is better off for it. Even though I was around I remember the day as if I were. It definitely resonates with me and I appreciate what those folks have done.
