1. **Resolution No. 20-25** A RESOLUTION AUTHORIZING AND DIRECTING THE DIRECTOR OF PUBLIC SERVICE FOR THE CITY OF NEWARK, OHIO, TO ENTER INTO A LEASE-PURCHASE AGREEMENT WITH PARK NATIONAL BANK FOR THE LEASE- PURCHASE OF TWO POLICE CRUISERS FOR THE DIVISION OF POLICE.

EMERGENCY REPLACEMENT OF THE INLET APRON AND CUT OFF WALL ON SFN 4501233.  
THIS WORK WILL BE PERFORMED AS PART OF PID 113225, LIC-SR16-23.68

**City Engineer David Morehead** – The culvert under State Route 16 west of Dayton Road, with the last heavy rains we had on March 19<sup>th</sup> and 20<sup>th</sup>, there was some damage on the north side of the culvert. We would like to cooperate with ODOT to get that done. All the work in the right of way of State Route 16 would be ODOTs cost. There is some work north of there that would be the city's cost. We would use our storm water utility funds to do that. We want to avoid the problems that the City of Heath had with the culvert under State Route 79. It does have an emergency clause in it. ODOT wished to move forward as quickly as possible on it.

**Mr. Rath** - Do we have an idea of the cost to the city?

**Mr. Morehead** - We do not know the expected cost yet. We are still working through all of that.

**Mr. Rath** – Do we know when they plan to start on this and the duration of the work?

**Mr. Morehead** – I believe they want to get the bid out in early May and begin work in June, I don't know how long it will take.
