WHEREAS, this Council authorized by Ordinance 24-43, the placement of a lien against the property located at and known as 45 South Morris Street, Newark, Ohio, Parcel ID #054-208398-00.000 in the amount of \$3,400.00 as and for costs incurred by the Property Maintenance Department with respect to certain property maintenance violations at such property; and,

WHEREAS, the property maintenance violations that gave rise to the placement of the aforementioned lien upon the property have been successfully resolved; and,

WHEREAS, this matter was considered in regular session by the Safety Committee who voted to refer the same to full Council for consideration; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NEWARK, COUNTY OF LICKING AND STATE OF OHIO, THAT:

SECTION ONE: The Director of Public Safety is hereby authorized and directed to release the lien previously authorized by the Council at Ordinance 24-43 as against the property located at and known as 45 South Morris Street, Newark, Ohio, Parcel ID #054-208398-00.000 and to prepare, execute, and record any and all necessary documents to facilitate the release thereof.

SECTION TWO: This Resolution shall become effective at the earliest time permitted by Article 4.07 of the Charter of the City of Newark, Ohio.
