Parking Regulations Summary

- **452.03 PROHIBITED STANDING OR PARKING PLACES.**

No person shall stand or park a vehicle, except when necessary to avoid conflict with other traffic or to comply with the provisions of this title or while obeying the directions of a police officer or a traffic-control device, in any of the following places. See Section 407.10 for parking infraction fines.

- (a) On a sidewalk, except a bicycle or motorized bicycle;
- (b) In front of a public or private driveway;
- (c) Within ten feet of either side of a public street or highway where the same intersects an alley or within five feet of either side of a public or private drive where the same intersects a public street or highway;
- (d) Within an intersection;
- (e) Within ten feet of a fire hydrant;
- (f) On a crosswalk;
- (g) Within 20 feet of a crosswalk at an intersection;

- (l) Alongside or opposite any street excavation or obstruction when such standing or parking would obstruct traffic;
- (m) Alongside any vehicle stopped or parked at the edge or curb of a street;
- (o) At any place where signs prohibit stopping, standing, or parking, or where the curbing is painted yellow, or at any place in excess of the maximum time limited by signs;
- (p) Within one foot of another parked vehicle;

452.04 MANNER OF PARALLEL AND ANGLE PARKING; PERSONS WITH DISABILITIES/PRISONERS OF WAR.

(c) No vehicle shall be stopped or parked on a road or highway with the vehicle facing in a direction other than the direction of travel on that side of the road or highway.

(f) (1) No person shall stop, stand, or park any motor vehicle at special parking locations provided under division (e) of this section, or at special clearly marked parking locations provided in or on privately owned parking lots, parking garages, or other parking areas and designated in accordance with that division, unless one of the following applies:

452.07 OPENING DOORS ON SIDE AVAILABLE TO TRAFFIC.

(a) No person shall open the door of a vehicle on the side available to moving traffic unless and until it is reasonably safe to do so, and can be done without interfering with the movement of other traffic, nor shall any person leave a door open on the side of a vehicle available to moving traffic for a period of time longer than necessary to load or unload passengers.

454.06 MARKING SPACES; PARKING WITHIN SPACES.

The Service Director, as requested by the Safety Director, shall have lines and markings painted upon the street for the purpose of designating the parking space for which zoned parking is to be used, and any vehicle shall park within the lines or markings so established.

No person shall park any vehicle, or cause or permit any vehicle registered in the name of or operated by such person, to be parked across any such lines or markings, or park or cause or permit to be parked any vehicle in such a position that the subject vehicle is not entirely within the area so designated by such lines or markings.

454.07 MANNER OF PARKING.

(a) When a parking space is parallel to the curb or sidewalk, no vehicle parked in such parking space shall be parked otherwise than with the front end of such vehicle facing the direction of traffic.

454.09 OVERTIME PARKING.

(a) For purposes of this section and Sections 454.06 and 454.07, “thirty-minute free parking space”, “three-hour free parking” and “eleven-hour parking” means:

(1) Spaces designated and marked as such by the Safety Director pursuant to the Director's rule-making authority provided for in Chapter 406.

(2) Spaces other than spaces marked for people with disabilities.

(b) Moving from one, thirty-minute free parking space to another thirty-minute free parking space within three-hour period is prohibited except where the total of thirty minutes has not been exceeded.

(c) Moving from one, three-hour free parking space to another three-hour free parking space within a three-hour period is prohibited except where the total of three hours has not been exceeded. Moving from one, three-hour free parking space to another three-hour free parking space is permitted even if the total of three hours has been exceeded if the vehicle in question has left all three-hour free parking zones as identified in division (d) of this section for a minimum consecutive intervening period of three hours.

(d) Three-hour free parking zones are located on:

(1) West Main Street from Fourth Street to Third Street;

(2) East Main Street from First Street to Second Street;

(3) South Second Street from Church Street to Scheidler Street;

(4) Third Street from Church Street to Market Street;

(5) North Park Place from Third Street to Second Street;

(6) South Park Place from Third Street to Second Street;

(7) Church Street from Fourth Street to Second Street with the exception of those spaces designated as thirty-minute free parking spaces pursuant to division (e)(1) and (2) of this section;

- (8) Fourth Street from Locust Street to Market Street;
- (9) West Main Street from Fourth Street to Fifth Street;
- (10) North Third Street from Locust Street to Church Street.

(e) Thirty-minute free parking zones are located on:

(1) South side of West Church Street from the west end of 27 West Church Street to the east end of 5 West Church Street as posted;

(2) South side of East Church Street directly in front of 15 East Church as posted.

(f) Eleven-hour free parking zones are located on:

(1) Fifth Street from Locust Street to Market Street;

(2) Church Street from Fifth Street to Fourth Street;

(3) Second Street from Church Street to Locust Street;

(4) First Street from Locust Street to Market Street;

(5) Church Street from Second Street to Front Street.

(g) No person shall cause, allow or permit a vehicle to occupy a designated thirty-minute free parking space during the times set forth in division (j) of this section for more than thirty minutes within the thirty-minute free parking zone.

(h) No person shall cause, allow or permit a vehicle to occupy a designated three-hour free parking space during the times set forth in division (j) of this section for more than three hours within the three-hour free parking zone.

(i) No person shall cause, allow or permit a vehicle to occupy a designated eleven-hour free parking space during the times set forth in division (j) of this section for more than eleven hours per space per day.

(j) The limitations set forth herein shall be in operation from 8:00 a.m. until 5:00 p.m., Monday through Friday, excluding the following observed holidays: New Year's Day, Martin Luther King Day, Presidents' Day, Memorial Day, Independence Day, Labor Day, Veterans' Day, Thanksgiving Day, the Friday after Thanksgiving, Christmas Eve Day and Christmas Day.

454.10 LOADING OR UNLOADING MERCHANDISE.

Commercial trucks may park in the parking zones to load or unload merchandise for a period not exceeding thirty minutes. No such commercial truck or delivery vehicle shall be parked in such zones longer than thirty minutes.
